<p>Due to the implementation of a new electronic document system in Brazilian Customs (Siscomex Carga), there will be some changes on the consignment instructions. Please consign shipment exactly as follows: <b>(these are mandatory)</b></p> <ul style="list-style-type: none"> <li>▪ Full name (As listed on the passport without using the terms "Mr.", "Mrs.", "Ms" nicknames or abbreviations)</li> <li>▪ CPF Number (Shipper must inform you) – All residents in Brazil have this number <b>(this is the Brazilian tax payer ID)</b></li> <li>▪ Passport Number</li> </ul> <p><b>When a shipment arrives to Brazil, customs clearance process cannot be started if pre-registration (credenciamento) of customer at customs is not completed.</b></p> <p><b>To pre-register customer we need the following documents at least 5 working days before shipment arrives to Brazil:</b></p> <ul style="list-style-type: none"> <li>▪ Customer ID card or protocol, Brazilian Social Security - CPF - or protocol.</li> <li>▪ Power of attorney.</li> <li>▪ Bill of lading</li> </ul> <p>If Contents: Used household goods and Personal Effects: <b>mandatory code <u>NCM 9797</u></b>            If Contents: Diplomatic Cargo Status / Diplomatic Used household goods and Personal Effects/ Diplomatic Automobiles: <b>mandatory code <u>NCM 9898</u></b></p> <p>Please also have the following information properly declared on the OBL (Original Bill of Lading):</p> <ul style="list-style-type: none"> <li>▪ OBL must be rated showing the freight cost ("as per agreement" is not allowed);</li> <li>▪ Correct and true gross weight in kilos only ("pounds" is not allowed);</li> <li>▪ Measurement in cubic meters only ("cubic feet" is not allowed);</li> <li>▪ Description of goods and number of volumes according the packing list.</li> <li>▪ The Harmonized Code for HHGDS</li> </ul> <p><i>i.e.: 2 wooden lift vans STC 70 packages of used household goods and personal effects or 150 packages loose packed in 1x20' CNTR</i></p> <p><b>There will be no exceptions and any Bill of Landing issued without all the information required (as outlined in the consignment instructions) will be subject to fines varying from US\$ 5,000 to US\$ 20,000 for correction.</b></p> <p><b>The required information is the following:</b></p> <ol style="list-style-type: none"> <li>1) Bills of Lading to be Consigned to SHIPPER (owners complete name). This is a must. Don't consign shipment to Moving Company or any Company.</li> <li>2) Full address - can be the movers full address but without movers name.</li> <li>3) Shippers CPF Number (Brazil Income Tax number)</li> <li>4) In the body of the Bills of Lading, the Customs Commodity Code for household goods/personal effects must be shown.</li> </ol> <p><b>For individuals other than diplomats: NCM 9797</b>  <b>For DIPLOMATS: NCM 9898</b></p>

<p><b>Removal goods</b></p>	<p><b>Temporary work visa</b> (one year or more)</p> <ul style="list-style-type: none"> <li>• B/L or AWB.</li> <li>• Airline Ticket.</li> <li>• Visa must be valid for more than 180 days.</li> <li>• Passport and visa.</li> </ul> <p><b>Permanent visa</b></p> <ul style="list-style-type: none"> <li>• Airline Ticket.</li> <li>• Passport and permanent visa to be obtained before arrival in Brazil.</li> <li>• Original of the inventory list, signed by the customer. This list must be translated in Portuguese (no need of official translator), detailed and with values in US Dollars.</li> <li>• Original of the bill of lading or airway bill.</li> <li>• Notarized power of attorney authorizing the Brazilian agent to represent the customer in the clearance (agent will furnish this form after arrival of the customer in Brazil).</li> <li>• Notarized copy of the Brazilian identification card (RNE)</li> <li>• Notarized copy of the Brazilian tax card (CPF).</li> <li>• Notarized copy of the airplane ticket, showing the entry in Brazil.</li> <li>• Customers with visa must register at the Federal Police Department in Brazil for the customs clearance of the move</li> <li>• Goods must arrive to Brazil within 180 days from the day Brazilian Federal Police stamps the passport.</li> <li>• Immigration declaration from Brazilian Federal Police showing that any eventual entries in Brazil did not exceed 45 days in</li> </ul>	<p>Duty free entry of goods and new items for personal use provided that these are:</p> <ul style="list-style-type: none"> <li>• Not for commercial purposes</li> </ul> <p>The above does not apply to consumer items such as foodstuff, diapers, cosmetics, candles, paint, etc. which are not considered by Brazilian customs as household goods and cannot be included in the move.</p> <p><b>Temporary Visa (work visa)</b></p> <ul style="list-style-type: none"> <li>• Duties are suspended for the same period as the validity of the visa. New articles are admitted given that duties are suspended but all articles brought into the country must be re-exported before the visa expires, otherwise duties and fines are imposed.</li> <li>• Foreign nationals with temporary visa must sign a re-export guarantee. This guarantee will cover the amount of duties based on the inventory, considering 50% of the declared value.</li> </ul>	<p>All shipments are required to have the client's CPF (Cadastro de Pessoas Fisicas - Brazilian Social Security number) card number mentioned on the original Bill of Lading. Delays and possible charges (port storage and demurrage) will be caused if CPF card number is not listed</p> <ul style="list-style-type: none"> <li>• Customs authorities will not authorize Customs clearance of HHGDS shipments without a proper visa.</li> </ul> <p><b>For Permanent/Temporary visa</b></p> <ul style="list-style-type: none"> <li>• Goods must arrive to Brazil within 180 days following the entry of the owner into the country using the issued visa. The clearance process should be initiated up to 45 days after the shipment arrival.</li> <li>• Shipment must originate from the same country of the owner's nationality or where he was living at the time of shipment.</li> <li>• For returning Brazilians a certificate of residence abroad for minimum one year must be obtained at the Brazilian Consulate at origin country to avoid taxes.</li> <li>• Port and airport charges can get extremely high in the case that a shipment is kept in the port (or airport) terminals without being cleared due to a lack of visa.</li> <li>• After 45 days of an import in the port/airport without the customer or its representative/customs broker having started the customs process, customs have the right</li> </ul>



<b>Prohibited Articles</b>		<ul style="list-style-type: none"> <li>• Flammable or corrosive materials.</li> <li>• Personal computers (only allowed if listed in the inventory with value in US Dollars).</li> <li>• Foodstuff, sausages (all subject to high duties). Only a reasonable amount of canned or packed goods must be shipped, except for temporary visa holders.</li> <li>• Handguns and ammunition must be in a list with a visa from the Consulate. These must be registered at the Brazilian Army before their release by the Customs.</li> <li>• Jewellery, currency or valuable articles.</li> <li>• Drugs and medicines (unless there is a doctor's prescription).</li> <li>• Engines and vehicles (unless in the case of diplomatic shipments).</li> <li>• High value coins or stamps collections.</li> <li>• Tobacco (free up to 400 cigarettes or 25 cigars or 250 of tobacco for pipe) High duties are applied.</li> <li>• Wines and alcoholic beverages (2 litres max.)</li> <li>• Customers with temporary visa will always be subject to the payment of duties.</li> </ul>	<b>Arms, Ammunition, dangerous objects</b> Subject to consultation with the Brazilian Army prior to departure from country of origin. Small calibre only, for personal use, hunting rifles. No dangerous objects allowed. Guns and ammunitions will be retained until inspected by the army officials.

		<p>International Trade (aka NIFM-15) to standardise the treatment of wood packing materials used for the transport of goods.</p> <p>Effective September 2005, shipments into or out of the country in wooden packaging, need to have a Seal, certifying that these have received the required treatment (HT = Heated Treatment - a minimum wood core temperature of 56°C for a minimum of 30 minutes; or fumigation with Methyl Bromide (MT).</p> <p>The minimum temperature should not be less than 10°C and the minimum exposure time should not fall below 16 hours.</p> <p>The treatments established in the present regulation intend to reduce the introduction and/or the dissemination of quarantine plagues associated to the wood packing.</p> <p>The wood packing material must be marked in a visible location on each article, on at least two opposite sides of the article with a legible and permanent mark in black ink. Labels and adhesives are not allowed.</p>	<p>and pressure, or a combination thereof</p> <ul style="list-style-type: none"> <li>• Plywood sheets &amp; agglomerated sawdust sheet</li> <li>• Oriented wooden fibre sheets</li> <li>• Sawdust &amp; Wooden fibre</li> </ul> <p>Air and sea shipments to Brazil which are not fumigated , may be fumigated in Brazil at the cost of about US\$200.00; This would add 1-3 days delay to the clearance process.</p> <p>Items which may adversely a be affected by the fumigation chemicals, including foodstuffs, condiments, etc; should be tightly wrapped and sealed in plastic prior to the shipping.</p>
